#### **DEED RESTRICTIONS**

Bill & Stan met with several county officers last week to clarify FHE and Pasco County Deed Restrictions. The results follow.

#### Trailers per Code include travel trailers, RV's, Motorized homes, pickup coaches, boats, boat trailers and noncommercial utility trailers.

These vehicles must be stored in the back yard or side yard behind the front line of the home.

If you have your vehicle at your home for use over a weekend or holiday, storage must still be on the side or in back of the yard.

These vehicles may be **temporarily** parked in the front yard for loading, unloading, and cleaning

**only.** When this is complete, the vehicle must be moved to the back or side yard. At no time, may the vehicle be stored in the front of your home, nor can the sidewalk be blocked.

At last, we have a white sand beach! This new water-front park is on a 70-acre Spring fed

lake with white sand beaches. There are water sports, several volleyball courts, and other amenities. Although there are **No Lifeguards**, the water appears very shallow close to shore, perfect for smaller children. There is a \$5.00 parking fee for all cars. We are really looking forward to taking the Grands (grandkids) over the summer.

From our subdivision taking US Hwy 19N, it is approximately 18 miles to the left turn on Old Dixie Highway in Hudson, about 30 minutes drive. (Remember if you pass Little Road, you have gone too far on US 19N, and you need to turn around.)

### **Water Restrictions**

Although we are scheduled to get a LOT of rain over the next days, does not mean water restrictions will be lifted. It does mean, we won't have to water our yards and plants.

Remember if you have water build up in your back yard, be sure to open your gate and give the water a path to the street and drains. If you have a pool, you may want to lower the water level now to prevent overflow. (Water has come close to our back door only once in 8 years, but opening our gate helped alleviate the problem.)

## Progressive Waste Solutions-Regular Garbage Pick-up

The following items **will not** be picked up by Progressive Waste regular garbage pickup:

- Amount set out **over 6 item-limit**
- Non-regulation container size. Maximum size is 33 gallon or 50 pounds. All cans over 33 gallon must be bagged.
- Brush longer than 4 feet, OR not bundled and tied.
- Trash **not** in bags or cans.
- **Hazardous materials** in trash or garbage. Most common materials: pesticides, paint, pool chemicals.
- Large bulk items such as mattresses

## **RECYCLING:**

To recycle all the used batteries accumulated for the holidays, take them to our local library on Mile Stretch.

Paper —Newspaper, Boxes, broken down flat, Envelopes, Any clean paper

- 1. Pasco Schools have recycle bins that earn revenue for the schools. (Nearest to FHE— Sunray Elementary next to Publix on Sunray).
- Other County recycle bins earn revenue for Libraries, parks, and fire stations. (Nearest to FHE South Holiday Library on Mile Stretch, bin located in back of Library.)

#### **Open-faced Tangy Tuna Melts**

2 cans of tuna, drained
2 green onions, chopped
1 teaspoon Lemon Juice
1/2 cup chopped parsley (I've used dried)
1/4 teaspoon salt
Pinch of pepper
1 carrot & 1 stalk of celery, grated
1 glove of garlic minced (also optional)
2 Tablespoons of diced sweet pickle or relish

1/3 cup mayo

- $1\ 1/2$  ripe avocados, halved (good for you but you
- but may want to skip) 6 Slices Monterey Jack Cheese Sliced tomatoes
- 6 slices whole grain bread (healthier)

Mix the first 9 ingredients (Tuna through pickles) Until well mixed.

Add Mayo and mix evenly.

Preheat skillet on medium.

Place half avocado slide on each slice of bread, Place tomato slices on top of avocado.

Spread tuna mixture evenly over tomatoes, top with slice of cheese. Put bread in skillet and cover until cheese is melted and bread is toasted on bottom.
