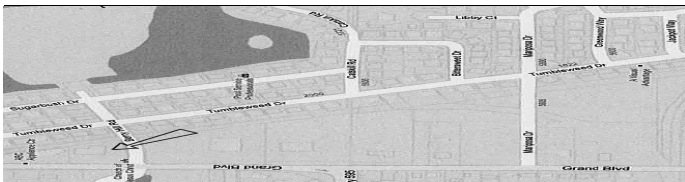

**If you have reported suspicious activity before, do it again. If reporting stops, it will be assumed the problem has been solved.**

I was told by a Local Sheriff's deputy this is important and may be the reason some of our biggest concerns have not been eliminated.

**The Pasco County Code Enforcement Officer attended our March meeting. Here are a few of the items that were discussed:**

1. There is No Parking on the streets.
2. Trailers can be parked along side of your home except if you live on a corner lot. Otherwise your trailer must be parked in your back yard.
3. House numbers must be on your home.
4. All cars must be registered and operational. The fine for junk cars is \$125.00.
5. Your yard must be properly maintained. If you are cited for an overgrown yard the fine is \$150.000.
6. Pools must be maintained. If you are cited for not maintaining your pool the fine is \$125.00. All pools gates must be secured with a lock. The fine for unsecured pools is \$500.00.
7. Pasco County remains on a one-day-a-week lawn watering schedule. Please go to <https://www.pascocountyfl.net/172/Water-Restrictions> to learn which day of the week you are allowed to water you lawn.
8. **Sec. 14-97. - Dogs Running at Large**—It shall be a violation to allow a dog to roam, wander, or run at large. Any dog that is on private property without the consent of the property owner or resident may be captured in a humane trap or otherwise confined. Contact Animal Services within 24 ours of capture.

## ***Treasurer's Report***

The Treasurer reported \$2,076.72 in checking and \$116.00 in savings. Monies spent were \$503.78, monies received were \$1,306.00. There is \$812.00 remaining for the year.

There are approximately 52 paying members with 240 registered homes. The Treasurer will be sending a form letter to all non-resident homeowners.

Letting our Commissioner and local officials know we are interested and active in keeping our subdivision a place we all want to live.

Maintain the entrance to the Subdivision. Notice other local subdivision entrances that are no longer maintained. It is not the appearance we want for our entrance. The association funds some of the cost of materials though all of the maintenance work is donated.

Everyone reacts differently to stressful situations such as an infectious disease outbreak that requires social distancing, quarantine, or isolation. People may feel:

- Anxiety, worry, or fear related to:
- Your own health status
- The health status of others whom you may have exposed to the disease
- The resentment that your friends and family may feel if they need to go into quarantine as a result of contact with you
- The experience of monitoring yourself, or being monitored by others for signs and symptoms of the disease
- Time taken off from work and the potential loss of income and job security
- The challenges of securing things you need, such as groceries and personal care items
- Concern about being able to effectively care for children or others in your care
- Uncertainty or frustration about how long you will need to remain in this situation, and uncertainty about the future
- Loneliness associated with feeling cut off from the world and from loved ones
- Anger if you think you were exposed to the disease because of others' negligence
- Boredom and frustration because you may not be able to work or engage in regular day-to-day activities
- Uncertainty or ambivalence about the situation
- A desire to use alcohol or drugs to cope
- Symptoms of depression, such as feelings of hopelessness, changes in appetite, or sleeping too little or too much
- Symptoms of post-traumatic stress disorder (PTSD), such as intrusive distressing memories, flashbacks (reliving the event), nightmares, changes in thoughts and mood, and being easily startled .

Please contact your healthcare provider if you have any of these reactions for 2-4 weeks or more.

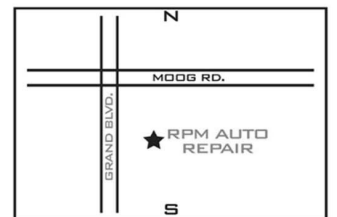

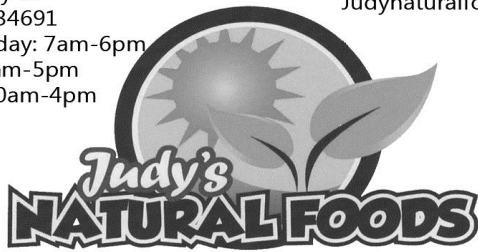
